Test, Train, Exercise



We train and deploy Vincentian volunteers. Teams are comprised of an Incident Commander, a Public Information Officer, a Resource Coordinator, and Logistics Officer.



Grants Program

The DSC grant-making program supports Vincentian Councils and Isolated Conferences with essential funds for disaster response and recovery. Targeted grants aid logistics, rapid response, and recovery efforts, enhancing community resilience.



Parish Recovery Assistance Center

P-RACs are located in parish community centers and provide a holistic approach to Disaster Recovery. P-RACs provide immediate casework, resources, and connect survivors to vital community services.



House in a Box™



This program provides new furniture and furnishings to families that are reviewed and referred through the DCM process. The program is scalable to the the size of the family and starts at \$3400 for a family of four.

DSC has coordinated DCM programs in various forms for decades. Case managers assist survivor families in their long-term recovery by advocating for clients, appealing adverse decisions of federal, state, private insurers, and other recovery funding decision-makers.
